A RESOLUTION OF MARION COUNTY, FLORIDA SUPPORTING THE MARION COUNTY BOARD OF COUNTY COMMISSIONERS' APPLICATION FOR LOCAL GOVERNMENT WATER SUPPLY FUNDING ASSISTANCE FROM THE WITHLACOOCHEE REGIONAL WATER SUPPLY AUTHORITY FOR LOCAL WATER CONSERVATION PROGRAM EFFORTS.

WHEREAS, the Board is seeking a grant through the Authority's funding assistance program for landscape and irrigation retrofits, toilet rebates, low-flow retrofit kits and homeowner-education elements of its overall water conservation programming in Fiscal Year 2020/2021; and

WHEREAS, the Board is required, according to the terms of the Authority's funding assistance program, to budget and expend matching funds equal to or greater than fifty percent (50%) of the amount of the requested grant;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, that:

- 1. Marion County Board of County Commissioners supports the application to the Withlacoochee Regional Water Supply Authority for local program funding for the 2020/2021 fiscal year.
- 2. Marion County Board of County Commissioners agrees to budget \$51,695 as part of its on-going Water Use Efficiency Program.
