

Vice Chair Kinnard called the Withlacoochee Regional Water Supply Authority (WRWSA) Board of Directors meeting to order at 3:31 p.m. and requested a roll call.

3. Introductions and Announcements

- b. Public Officials Liability Insurance Policy Recommended approval of policy renewal (included in 2022-23 budget).
- Bills to be Paid Recommended for ratification of August (\$14,636.33) bills and approval of September (\$30,216.66) bills.
- **d.** Third Quarter Financial Report -- Accepted as presented.
- e. Fiscal Year 2022-23 Calendar of Board Meeting Dates Recommended for approval: 11/16/2022, 1/18/2023, 3/15/2023, 5/17/2023, 7/26/2023, 9/20/2023.

f. Marion County Local Government Grants Program – Recommended for approval grant funding agreement line-item adjustments.

Mr. Estep moved, seconded by Mr. Curry, to approve the Consent Agenda Items 6.a., 6.b., 6.c., 6.d., 6.e. and 6.f., as presented. Motion carried unanimously.

7. As-Needed Technical and Engineering Services

Ms. Suzannah Folsom, WRWSA Executive Director, presented this item.

a. Authorization to Enter into Contracts with Qualified Firms

At its May 2022 meeting, the Board authorized staff to issue a Request for Qualifications (RFQ) for General Professional Engineering and Technical Services. Six (6) Statement of Qualifications (SOQs) were timely received, and all met the RFQ requirements. The six firms are listed below in alphabetical order.

Included as exhibits to this item are a summary of the SOQ scoring, and the proposed agreement template for these services. The agreements with these firms do not authorize any work; work is authorized through the issuance of subsequent Work Orders, which must be approved by the Board (see item 9.b. below). The agreements are to be effective October 1, 2022, the beginning of the new fiscal year; and are for a three-year period and may be extended for two one-year periods upon mutual written agreement of both parties.

Ms. Stone moved, seconded by Mr. Wiley, to (1) approve the recommended list of firms for award of contracts for General Professional Engineering/Technical Services, as presented above; and (2) authorize the Executive Director to enter into an agreement with each firm consistent with the contract template exhibit. Motion carried unanimously.

b. Authorization to Issue Work Orders

Contingent upon the Board's action on Agenda Item 7.a., staff recommends issuance of the following Work Orders for the General Engineering and Technical Services:

Hazen and Sawyer – The purpose of this Work Order is to provide general engineering and technical support services to the Authority Board and Executive Director on an as-needed basis. The Work Order amount is \$10,000.

INTERA – The purpose of this Work Order is to continue ongoing representation of the Authority on the Springs Coast Technical Advisory Board. The Work Order amount is \$10,000.

A copy of the proposed Work Orders were included in the Board's meeting materials as exhibits to this item.

Ms. Stone moved, seconded by Mr. Wiley, to authorize the Executive Director to issue: (1) Work Order to Hazen and Sawyer in an amount not to exceed \$10,000 for the period through September 30, 2022; and (2) Work Order to INTERA in an amount not to exceed \$10,000 for the period through September 30, 2022. Motion carried unanimously.

8. Phase 7 Irrigation System Audit Program – Contractor Selection

Ms. Suzannah Folsom, Executive Director, presented this item. At its July 2022 meeting the Board authorized staff to issue a Request for Quotes (RFQ) for Phase 7, Irrigation System Evaluation Program. Staff advertised publically on the DemandStar website, WRWSA website and in the Florida Administrative Weekly.

One quote was received in response to the RFQ. The submitted quote, by Eco Land Designs, LLC, meets the RFQ requirements. Mr. Jack Overdorff, RLA, is the president of the firm and has been conducting irrigation audits for the Authority under previous phases of the program. His work to-date has met and surpassed all contract requirements.

The proposed Cooperative Funding Initiative (CFI) agreement is anticipated to be approved by SWFWMD in November 2022. If, for some reason the Authority and the SWFWMD do not enter into a CFI agreement for this project, the contract with the contractor has provisions allowing the Authority to cancel the contract. If the Board approves the staff's recommendations, as presented below, the Authority's attorney will review and approve the final CFI agreement between the SWFWMD and the WRWSA before the Executive Director executes the agreement. The proposed Agreement between the contractor and the WRWSA was included as an exhibit to this item in the Board's meeting materials.

Mr. Curry moved, seconded by Ms. Stone, for the Board to approve the following action items and motion carried unanimously:

- a) Select Eco Land Design, LLC, as contractor to perform the irrigation system evaluations for Phase 7, Irrigation System Evaluation program (Q306);
- b) Approve the contract between WRWSA and Eco Land Design, LLC, in an amount not to exceed \$102,000; and authorize the Board Chair to sign the contract; and
- c) Authorize the Executive Director to sign the CFI agreement for Phase 7, Irrigation System Evaluation program, between the SWFWMD and the WRWSA, following review and approval by the Authority Attorney.

9. 2024 Regional Water Supply Plan Update - Request for Statements of Qualifications

Mrs. Suzannah Folsom, WRWSA Executive Director, presented this item. At the September 2021 meeting, the Board authorized staff to submit a cooperative funding request to the Southwest Florida Water Management District (SWFWMD) for the preparation of an updated Regional Water Supply Plan. The project Q324 is on the proposed list of cooperatively funded projects and is scheduled to be approved at the SWFWMD Board of Directors meeting on September 20, 2022.

The Authority staff is working with the SWFWMD staff on a cooperative funding agreement, which is anticipated to be presented to the Board at its January 17, 2023, meeting. The WRWSA 2024 Regional Water Supply Plan will be completed in 2024 so that information from the Authority's report can be used by the District as it updates its Regional Water Supply Plan. This project is included in the Fiscal Year 2022-2023 Budget for \$350,000 and will receive 50% cooperative funding from SWFWMD.

Staff is recommending the Authority begin the consultant recruitment process at this time. The purpose of this item is to obtain Board authorization to issue a Request for Statements of Qualifications for 2024 Regional Water Supply Plan Update. If approved, staff will return to the Board at its November 2022 meeting with a shortlist of firms to negotiate with, and at its January 2023 meeting with recommendations for entering into contract. In response to Ms. Stone's inquiry, Ms. Folsom said she reach to SJRWMD after the upcoming elections. Ms. Folsom said she is requesting a guest speaker for the Board's next meeting.

This item was for information only and no action was required.

11. Attorney's Report

Mr. Batsel noted that several of the agreements for Item 7 are lacking exhibits for certification of liability and fee schedule. Staff will request these documents and resubmit agreements for the Authority's attorney to execute.

 - a. **Charles A. Black Water Use Permit Renewal** The Wellfield WUP number 7121.006 is being reviewed and an extension of time has been requested.

 - b. Water Management Information System Water Use Permit Notifications A list of notifications was included in the Board's meeting materials. Ms. Folsom noted the large new Blue Goose permit for public supply in Sumter County.

 - d. **News Articles** Several articles included in meeting materials for the Homosassa River Restoration Project, Brooksville wastewater spill, Weekiwachee Preserve septic to sewer project, Citrus County's Three Sister Springs algae bloom, Inverness developing blueprint for environmental progress.

Financial Accounts, Bills to be Paid, and Payment Process

Ms. Suzannah Folsom, Executive Director, will present this item.

WRWSA funds are maintained in four accounts:

- 1. SBA1 Operating Account Funds
- 2. SBA2 Project Funds
- 3. Checking Account
- 4. Renewal and Replacement Fund

Our Renewal and Replacement Account is maintained by Citrus County to have a balance of between \$2 and \$3 Million, and is used to maintain the Charles A Black Wellfield and Treatment Plants.

We maintain two State Board of Administration Accounts with Florida Prime to maximize the return on our investments. These accounts are available for State Governments. The SBA 1 account is used for WRWSA operating funds for administrative expenses and is funded by a per capita assessment of the four counties, and interest from SBA 1 and SBA 2 accounts. The SBA 2 account is used for WRWSA project funds and is funded by CAB Wellfield supply sales to Citrus County and SWFWMD and cooperator reimbursements. In recent years, interest from these accounts has ranged from \$3,000 to \$42,000 per year depending on the Florida Prime rates, however we do not include this revenue in our budget, as the interest rates are unpredictable.

Our Truist Checking is used to pay our monthly bills, and is funded via monthly transfers from SBA1 and SBA2. We maintain a minimum balance of \$15,000. Our monthly Bills to be Paid are reported at each board meeting. Checks are typically signed by the Executive Director and Board Chair.

We manage our accounting using Quickbooks software. Every month we reconcile our bank statements. Each quarter we post our books and have quarterly and annual audits by Purvis Gray.

In August, we missed a transfer from SBA 2, and subsequently bounced a check to Marion County for their conservation grant funding reimbursement. We have made payment to Marion County via cashiers check, including a 5% fee.

In order to make sure this does not occur again, we plan to increase our minimum balance in our Truist checking account to \$30,000, and have an signed up for an online banking login so that we can check our real time bank balance weekly.

The Bills paid for October and November reflect these events.

Staff Recommendation:

Board ratify bills paid in October 2022 and approve bills for payment in November 2022, including an increase in our Truist Checking account to maintain an minimum balance of \$30,000.



<u> 2024 Regional Water Supply Plan Update – Consultant Selection</u>

Ms. Suzannah Folsom, Executive Director, will present this item.

At its September 21, 2022 meeting, the Board approved issuance of a Request for Qualifications (RFQ) for purposes of soliciting consultant interest in undertaking the Authority's Regional Water Supply Plan Update project. Two consulting firms responded to the RFQ, including (listed alphabetically):

Charles A. Black Wellfield Fiscal Year 2021-22 Revenues

Mrs. Suzannah Folsom, WRWSA Executive Director, will present this item.

The end of Fiscal Year 2021-22 represented the sixth full year operating under the revised Water Supply Contract with Citrus County. The purpose of this agenda item is to report to the Board the status of water sales to Citrus County and corresponding revenues for the fiscal year. The FY 2022-23 budget included the minimum contract charge of \$224,000. The revenue received reflects a surplus revenue of \$49,428.15.

Minimum Flows and Levels – Priority Lists and Schedules

Suzannah Folsom, WRWSA Executive Director, will present this item.

The purpose of this item is to provide a status report to the Board of the establishment of minimum flows and levels (MFLs) in the Authority's four-county area.

Chapter 373, Florida Statutes, requires each of the water management districts to have a Priority List and Schedule for the establishment of MFLs. This Priority List and Schedule identifies water bodies for which the District plans to establish minimum flows and levels and also identifies planned water reservations. Minimum flows and levels are limits set by the District Governing Board for surface waters and groundwater systems that are intended to prevent significant harm to the water resources or ecology of the area that may be caused by water withdrawals. Reservations set aside water from withdrawals for the protection of fish and wildlife or public health and safety.

The Districts are required to update this List and Schedule each year and provide the updated List to the Florida Department of Environmental Protection (DEP) by November 15th.

Included as exhibits to this item are the MFLs that have been established to-date, and the proposed Priority Lists and Schedules for waterbodies within the WRWSA four-county area that are to be approved by the District Governing Boards for submittal to the DEP in November. A GIS map of the MFL locations and the current status of the MFL are provided by the DEP Office of Water Policy at:

The Water Management Districts will use these MFLs to assess the health of the environment and will limit the issuance of future water supply permits based on monitoring these locations.


All MFLs are currently being met except for the Silver Spring MFL, which is listed as "Prevention" which means that the SJRWMD has a Prevention Strategy in place to bring it back to "Meeting" the MFL. This strategy includes conservation, aquifer recharge with the Ocala wetland aquifer recharge park, relocating supply to the lower Floridan aquifer, and increasing use of reclaimed water for irrigation.

The most relevant upcoming MFLs to be set will be four locations along the Withlacoochee River to be set by 2024. The Withlacoochee River has been identified as a potential alternative water supply source for the region, but the potential quantities that could be available cannot be determined until the minimum flows are set. WRWSA will continue to monitor and report on efforts to set these MFLs.







PFAS Legislation – presentation for meeting

Legislative Report

Mr. Viraj deSilva, Freese and Nichols will present this item.

The 2023 Legislative Regular Session will begin March 7, 2023 and end May 5, 2023. Staff will gather information on relevant bills that are related to conservation and water supply from SWFWMD, 1000 Friends of Florida, and the Florida Engineering Society's Conservation and Environmental Quality Committee, and the House and Senate websites.

One bill that we tracked during the 2022 legislative session was SB 7012/HB 1475 on PFAS, which was sponsored by Senator Albritton and Representative McClure. This Bill included:

- Creating the task force within the Department of Environmental Protection.
- Providing the membership, organization, and duties of the task force.
- Requiring the department to provide staffing to assist the task force in the performance of its duties.
- Requiring the task force to convene by a specified date.
- Requiring the task force to submit an annual report to the Governor and the Legislature by a specified date.

Mr. deSilva will give and overview on PFAS as an emerging contaminant and will present on the potential concerns within the WRWSA service area for public water supply.

Charles A Black Wellfield Water Use Permit Renewal

Ms. Suzannah Folsom, Executive Director will present this item.

The Charles A. Black Wellfield Water Use Permit number 7121.006 expired on March 13, 2022. Withlacoochee Regional Water Supply Authority is a co-applicant with Citrus County. The wellfield consists of seven public supply drinking water wells. The current permit has an average supply of 4,597,000 gallons per day (GPD) and a peak flow of 6,574,000 GPD.

Citrus County hired Jones Edmunds and Associates to assist in preparing the permit renewal application. WRWSA staff reviewed the permit application and provided comments prior to submittal. The following actions have been taken in the renewal process:

The requested term is 20 years, with an average permitted supply of 7,181,900 GPD and a peak supply of 9,121,013 GPD. This increase in capacity is based on population projections. 

The rate in fiscal year 2022 was \$0.1417 per 1,000 gallons. In an email on October 25, 2022, your staff confirmed that Citrus County is adjusting the rates applied to your customers by 5.0% in fiscal year 2023. The Master Water Contract allows for the same adjustment to be applied to the water rate that WRWSA charges Citrus County. The new calculated rate for fiscal year 2023 will be \$0.1487 per 1,000 gallons.

Florida Springs Council's plan shows springs restoration, though difficult, is achievable

We've all heard the saying, "If you want something done right, do it yourself." When it comes to creating a better Basin Management Action Plan (BMAP) for the Santa Fe River, that's exactly what the Florida Springs Council did.

The purpose of a BMAP is to reduce water pollution levels back down to the point where we don't have algae blooms and mass manatee die-offs, or get sick from going into the creeks in our backyards. For Outstanding Florida Springs — like Ichetucknee, Poe, Silver and Rainbow — the law requires these plans to achieve water quality goals within 20 years.

In 2018, the Florida Department of Environmental Protection proposed BMAPs for 24 impaired Outstanding Florida Springs. Several of these, including the BMAP for springs of the Santa Fe River, fell woefully short of that basic statutory goal.

The most obvious failing in the Santa Fe BMAP is that it only proposes a small fraction of the nitrate reductions necessary to clean up the springs. At the same time, it ignores the increased pollution that will inevitably occur in the next 20 years from population growth and greater agricultural intensity.

At best, DEP's BMAP is a prescription for treading water. At worst, our springs will be more polluted in 20 years than they are today.

Paddlers navigate kayaks around Poe Springs, which is noticeably green in color, at Poe Springs Park in High Springs in 2021.

In response, a handful of Florida environmental groups and several brave individuals challenged the legitimacy of five Outstanding Florida Springs BMAPs in court. We expect a ruling from the First District Court of Appeals on those cases soon.



During this long legal process, the Florida Springs Council concluded that, since the state was shirking its responsibility to create a credible BMAP, we would do it ourselves. The result is a "Better BMAP for the Santa Fe River Springs," available at floridaspringscouncil.org/betterbmap.

What makes a small non-profit think it can write a better BMAP than a state agency with a multibillion annual budget?

We have the great advantage of caring not a whit about political considerations but only the health of the springs. Unlike DEP, we're honest about the scope of the problem and the seriousness of the measures that will have to be undertaken to reverse decades of manmade degradation.

Everyone agrees that we must reduce nitrate pollution in the Santa Fe River basin by approximately two-thirds, or 1.8 million pounds per year. That's no small task. DEP's BMAP only gets us about a quarter of the way there. So what will it take to restore the Santa Fe?

Crowds swim and float at Ginnie Springs in High Springs.

First, we have to stop making the problem worse. That means requiring all new residential and commercial developments to connect to advanced wastewater treatment facilities, prohibiting inground lawn irrigation systems and the use of lawn fertilizer containing nitrogen on new lots, and placing a moratorium on new agricultural water use permits.

Then we have to deal with the existing pollution by allocating the required nitrate reductions to specific categories of pollution sources (farm fertilizer, septic tanks, urban fertilizer, etc.), and finding policies and projects capable of achieving those reductions.

In the case of the Santa Fe River, and many other Florida waters, agriculture is the major source of pollution and, therefore, must be responsible for the vast majority of the reductions. While urban fertilizer and septic tank pollution are real issues that must be addressed, even if they were eliminated the springs of the Santa Fe River would still not meet water quality goals.

The challenge is showing how agricultural pollution can be cut by approximately 70% percent in a state where farmers have the legal right to pollute our waters. It will involve more advanced agricultural practices, like precision fertilizer placement and soil-moisture sensors, but more importantly it will require large-scale conversions of intensive agriculture to non-polluting land uses like forestry.

These initiatives will require legislation creating a new type of groundwater and nutrient conservation easement and ongoing ecosystem payments for farmers willing to convert their lands, as well as hundreds of millions of dollars in funding annually from the state to implement.

Our "Better BMAP" is intended to show the people of Florida, as well as our elected and appointed leaders, that springs restoration, though difficult, is achievable.

In the end, we can only hope that they will take our recommendations seriously. If not, they should have the decency to admit that, although recovering our springs is a worthy and achievable goal, they don't have the political will to make it happen.

Wildwood leaders hold special meeting to discuss yellow, brown water issues facing residents

WILDWOOD, Fla. — Residents of one Central Florida city said they are tired of dealing with discolored water and that they have been dealing with the problem for weeks.

The city of Wildwood held a special meeting on Monday to talk about the water problem and what city plans to do to fix the issue, permanently.

During Monday's meeting, the city said the problem was a new water main connecting to a treatment plant that was causing extra pressure in the older pipes downtown, and that was knocking rust into the water that was causing the water to change color.

City officials maintain that the water has been safe to drink the entire time, but residents told Channel 9 that they won't drink it.

"If they feel like it's safe, each one of them can get a glass and then swallow, then I'll say 'okay, it is safe," said resident Carolyn Lewis. Lewis and her neighbors told Channel 9 that the water has been discolored for weeks and it is starting to stain sinks and bathtubs.

"We've definitely offered our sincerest apologies for this happening," said Wildwood Mayor Ed Wolf. "It's embarrassing. We're not going to try to dodge it." In Monday's special city council meeting, city leaders voted to give impacted residents 40% off their bill for this past month.

Leaders said the problem started with a new water main from the Oxford Water Treatment Plan which put extra pressure on the system changing the flow and knocking rust into the water from old galvanized pipes in the downtown area.

"So we're not going to bring the water from Oxford back down here until we have a better plan in terms of what we can do to rectify this so that this doesn't particularly happen," said Wildwood City Manager Jason McHugh.

Over the weekend, the city disconnected that line from downtown and flushed the lines. City leaders said it seemed to have cleared things up. Residents told Channel 9 that it did help and that the water is lighter, but still has a yellow tint to it.

The city said it will eventually have to change all the old pipes downtown for a more permanent solution, but they're hoping these new efforts will help for now.

Wildwood residents to see 40 percent discount in bill over discolored water

Wildwood residents suffering with discolored water will receive a 40 percent discount on this month's utility bill as the city takes steps to resolve the issue.

The City Commission voted unanimously at a special meeting Monday morning to offer the discount.

Eligible residents live in the older section of the city, roughly between the U.S. 301 overpass and State Road 44. Downtown businesses also were affected.

Iron residue in older pipes colored the water over the past several weeks after city workers connected a new pipeline, which increased the flow and shook loose deposits.

Utilities Director Mark Odell said the discolored water is safe to drink.

To address the issue, he said the new water main, which he calls the Peppertree line, has been disconnected from the older section of the system. The line runs south from Oxford and past the Peppertree Apartments.

Odell said employees also flushed 175 fire hydrants a week ago and are continuing an aggressive flushing routine, especially where complaints are received.

Money in the next fiscal year's budget, which begins Oct. 1, also will allow the city to replace some of the older galvanized pipe, he said.

Odell said the entire system will be treated with polyphosphates, which create a film over iron deposits to keep them from coming loose.

"It's embarrassing and we're not going to dodge it," said Mayor Ed Wolf. "I just think we should have anticipated the possibility of something like this happening."

Wolf said disconnecting the new line is a "temporary fix" because it must eventually be connected to the rest of the system.

"It may be a Band-Aid until we find out what we need to do," said City Manager Jason McHugh.

He said the flushing may be working because he received no new complaints on Monday morning.

Wolf said residents may want to flush their own pipes, which could have the same deposits, by turning on an outside hose. He suggested that the city could offer a credit for water bill increases due to flushing.

The problem became public when Lee Coffey, a resident of an older part of the city, complained about the discolored water and brought samples to a City Commission meeting last month.

Coffey said his toilet water was so yellow that it looked like he hadn't flushed it.

Wildwood approves \$2.3 million contract for new sewage treatment plant to cope with growth

Approving a \$2.3-million design and engineering contract, Wildwood commissioners Monday took the first step to upgrading the city's current sewage treatment plant and building a new one next to it, capable of handling six million gallons of wastewater daily.

The contract with CPH Engineers covers all pre-construction phases of both plants, including engineering design, construction loan applications, permitting and preparing site plans.

Wildwood's rapid growth in both the Villages of Southern Oaks and due to apartment construction elsewhere in the city have spurred the need for increased capacity from the 40-year-old treatment plant.



Wildwood's waste water treatment facility is 40 years old.

"We're growing a little faster than we anticipated so this goes on the front burner real quick," said Mayor Ed Wolf.

The current plant processes about 1.7 million gallons of wastewater daily, a 16.7 percent increase from a year ago.

Although the plant was designed to handle 3.5 million gallons a day, it's capacity is 2.8 million due to inefficiency. It is expected to reach capacity in about three years.

Construction could begin early next year, even before design and engineering work have been completed.

Last month, commissioners heard a report from Benjamin Fries, a CPH vice president, on the status of the current plant and a blueprint for expansion.

He recommended a two-pronged approach that includes upgrading the current plant and building a new plant on adjacent city-owned property.

CPH Engineers of Sanford also was hired earlier this year to prepare the report and commissioners voted Monday to accept the findings.

Fries said the current plant can be more efficient with piping changes that would distribute wastewater equally between two oxidation ditches.

The new plant would be built in phases and the old plant would continue operating until it is fully completed. Then the old plant would be demolished.
